The Tyllilang Multi - Purpose Cooperative Society Ltd. was formed on the 25<sup>th</sup> July, 2006 as a Group of 10 persons headed by Shri. Jowel Muktieh and the Late Shri. J.S. Shadap, as the President and the Secretary of the Group respectively.

It got itself registered in the Office of the Assistant Registrar of Cooperative Societies, Ri – Bhoi District, Nongpoh under the provisions of the Meghalaya Cooperative Societies Act & on the 10<sup>th</sup> August, 2006 with its headquarter at Mawlarnai (Mawbri) village, B.P.O. Mawbri, Ri – Bhoi District, Meghalaya. The Group was registered under the name of the ‘Tyllilang Industrial Handicraft and Allied Cooperative Society Ltd.’ but later on amended its name to “Tyllilang Multi – Purpose Cooperative Society Ltd” on the 10<sup>th</sup> September 2009. The aims for amendment of the above name was to be able to expands its activities to the others fields also for the benefits of the members and the people of the surrounding areas. Presently, the Cooperative Society has got a total strength of 19 members comprising of 09 female and 10 male.



The Group after being elevated to a cooperative Society in its 4 year of journey has received a Financial aids from the DCIC, Nongpoh through the DRDA under the BRGF Scheme for the year 2008 – 09 for the construction of the work shed in the land donated



by one of the member to the Society. The Society has also received Financial Assistance from the Government through the Office of the Assistant Registrar of Cooperative Societies, Ri – Bhoi District, Nongpoh for purchasing of raw material such as Bamboos etc and other

materials relating to handicraft activities and also had purchased various Machineries for helping and improving the Handicraft products of the fellow members.

The society has also been taken part in many exhibition conducted by the Department as well by the DCIC, Nongpoh. Besides the society has also taken part in the International Trade Fair (IITF) held at New Delhi twice. This exhibition has really give exposure for the society in



competing with other craftsmen within and outside the state.



Presently the Society is managed under the able leadership of the Chairman Shri. Jewel Muktieh and the newly appointed Secretary Shri. Joinder Phangcho. A bright aspect is seen ahead with more people of the area are interested to be the members of the society as awareness programme is being conducted from time to time by the Society, the DCIC as well by the IBDLP. Thus with the involvement of the various Department the society is sure to achieve new heights in

obtaining its objectives.
