La kumba 40(sawphew) snem ba ngi la ioh ia la ka jong ka State bad ka jingkiew ha ka jingbun ki Sengtreilang (Coopratives) ka la kiew suki pa suki ha kaba bun ki paidbah ki tur shakhmat ban seng ia ki Sengtreilang (Cooperatives). # **LYNNONG – I**

## **KA SENG TREILANG LANE COOPERATIVE SOCIETIES**

“COOPERATIVE” lane “COOPERATION” la ioh na ka ktien Latin “COOPERATI”. “CO” ka mut ka jingiasnoh kti lang bad “OPERATI” ka mut ban trei. Kumta ka jingmut “Cooperative” lane “Cooperation” ka mut ka jingtrei mon sngewbha da ka jingiasnoh kti lang jong ki briew ha kano kano ka jingthmu ban wallam ia ka jingiatylli bad ka jingjop ha baroh ki liang. Ban kham shai na ka bynta u kup shiliang u sem shiliang bad na ka bynta ka lawei ba phyrnai ia uwei pa uwei u nongkitkhlieh ia ka ioh ka kot ka jaidbynriew lah ban pynshai kumne harum ha ka dur jong ka jiangiathuhkhana.

Ka jingtrelang ha kawei ka jingmut ka thmu ia ka jingtrei ba iadon kti lang ha ka jingtrei jingktah u khun bynriew. Ka nongrim pyrkhat pyrdain jong ka jingiatrelang la lap ba ka long ka bor lane ka tiar ban pyntikna ia ka hok ha ka ioh ka kot ka imlang sahlang ia ki nongbylla bad ki nongtrei nongktah bad ka Sengtreilang la kylla long ka jingkhih paidbah ha satlak pyrthei lyngba ki Sengtreilang.

Ka kyndon ba 4(saw) jong ka Ain ki Sengtreilang ka Ri India 1912 (Indian Cooperative Societies Act 1912) ka batai shaphang ka Sengtreilang kum ka jingshongshit jong ki briew, kiba don ka jing thmu ia kajuh ban kyntiew ia ka ioh ka kot na ka bynta ki dkhot katkum ki thymmei lane nongrim jong la Sengtreilang.

Ka International Cooperative Alliance (ICA) ha ka jingialang ha Manchester ha u snem 1955, ka la pynmih ka jingthoh halor ka jingpynshisha shaphang ka jingmut bad ka dor jong ka Sengtreilang.

“Ka Sengtreilang ka dei ka Senglaitluid jong ki briew kiba iasnoh kti lang monlaitluid ban pynbiang pyndap ia kajuh ka jingdonkam ha ka roi ka par, ka imlang sahlang, ka riti ka dustur bad ka jingaimynsiem lyngba ka Seng ba ia dontilang bad ka pyniaid da ka jingsynshar paidbah.”

“Ka dor jong ka Sengtreilang la pynshing nongrim ha ka jingiarap iwei ia iwei, ka jingkitkhlieh ia iwei ia iwei, ka jingpyniaid paidbah, ka jinglong mar ryngkat bad ka jinglong kawei ha ka rukom im ki longshuwa, ki paradkhot, ka jingneit ha kid dor ka longbriew manbriew jong ka jinghok, ka jinglong ba la klo, ka jingkitkhlieh ha ka imlang sahlang bad ka jingda jingker ba ka bynta kiwei.

Ha ka shnong Mawsawa, la don 15 (khatsan) ngut ki long kpa kiba im sngi haka bylla bad ka bam rwing man la ka taiw.

Ka la dei ka sngi iew rit hapoh ka shnong ba markhap jong ka shnong Mawsawa bad kine ki 15 (khatsan) ngut ki long kpa ki la mih na la ki ing ki sem ban leit siew leit tda na ka bynta la ka jong ka iing ka sem.

Ka iew ha kata ka sngi ka long kaba shongshit ha kaba ki para marjan shnong ki wanrah ia ki mar rep, ki jingri jingdup ban ia die bad ban thied kylla pat na ka bynta ki jingdonkam ha iing ha sem bad ki khun ki kti. Kine ki 15 (khatsan) ngut na ka shnong Mawsawa ki long kiba im ja kpho tang da ka bylla sngi bad ka kyrduh ka shon ka ban jur ia ki kumno ban pyndap ia ka iing ka sem bad kim lah ruh ban ioh ia ki jingbam ba phyla kumba ioh lang kiwei pat ki marjan marpa ha ka shnong.

Uwei na kita ki 15(khatsan) ngut uba la jer bad sin da baroh kum u Bah Heh, u la poi ha kawei ka kyntoit/basa ka ba die ia li syiar ha kata ka iew, bad haba u la iohi ba katto katne ngut na ki para shnong ki la ia mih na kata ka kyntoit/basa bad kynthup lang bad ka syiar ha ka kti ka la pynjaw dud ia u bad u la kren wei bries ani! Ka jingkwah bam doh syiar, namar la bun snem ym ju ioh lad ban mad doh syiar shuh khamtam ha iing ha sem bad la ki khun ki kti, hynrei ha kane ka sngi, ynda u la twad dor ia kawei ka syiar lud na kita ki ruh syiar ba don hangta u la jew slew namar ym lah kot bor ban thied ia kata ka syiar bad ka la pynlong ia u ba yn phai lyndet noh nangta na kyntoit/basa ban peit bad thied ia kiwei pat ki mar kiba duna ban pyndap ia ka bam ka dih ia ka iing ka sem jong u.

Katba u dang iaid shakhmat u la iakynduh ia uwei u paralok ba la sin kum u khlain, ki la ia ieng shiphang ban ia sam kwai bad ia pur khana ia ki jingtrei jingktah, khamtam ia ka jingkwah bam doh syiar jong u , ka dor ka mur ha iew ha hat jong kata ka syiar, u Khlain ruh u la jawdud haba la ia pur ia kata ka jingkwah bam doh syiar namar u ruh ha ka juh ka kyrdan ym lah ban kot bor ban thied marwei, lane baroh arngut ban ialang ban thied ia kata kawei ka syiar bad kata ka jingkyrduh ka la pynduh ia ka jingthrang ka jingkwah bam doh syiar jong ki baroh arngut.

Hadien, ynda la kham noh phai ka sngi u Bah Heh u la iakynduh sa ia uwei pat u paralok na kita ki khatsan ngut ba la ju sin kyteng kum u Bah Kot, u Bah Heh u la pur khana ia ka jingiakynduh jong u bad u Khlain bad ia ka jing thmu bad jing thrang ban doh syiar jong ki baroh ar ngut kaba la pynlyng ia u Bah Kot ban thrang bad kwah ia kajuh, hynrei ia u ruh ka long ka jing eh namar u ruh um dap her na u Bah Heh bad u Khlain ha ka jingioh jingkot jong u.

Khatduh khatwai, kane ka jingthrang bad jingangud ka la poi sha ki skhor jong kita ki 12 (khatar) ngut ki paralok kiba sah, ki ruh kid a sngewbang bad thrang ka jingkwah bam doh syiar hynrei ka jinglot bor ha ka kamai kajih ka la pynlong iaki kum ba long u Bah Heh, u Khlain bad u Bah Kot ban pynduh ia kata ka jingkwah lane ka jingthrang ka jong ki.

Kane ka jingkwah bad jingthrang ban ioh mad doh syiar la kumno tang mar shi dkhot ka la ktah ia ki jingmut jingpyrkat jong kine baroh 15 (khatsan) ngut shi paralok. Kine ki shi paralok ha ka jing kynduh leit bylla man la ka sngi, ki la ia pur ia kajuh ka jingthrang bad khatduh ki la ia lum lang ha kawei ka jaka ban ia pyrkhat kumno ban leh ban ioh ban ia khawai doh syiar ialade bad ia ki khun ki

kti jong ki baroh. Hadien ka jingpyni jingmut iwei pa iwei, ki la ia rai lang ba hapdeng ka jingkyrduh kin ia kynshew pisa mar khyndiat ban kot ban thied kum 5 (san) tylli ki syiar ban ia shet lang ha kajuh ka jaka khnagn ban ia ioh mad doh syiar lang baroh 15(khatsan) ngut bad la ki khun ki kti, kumta ha katei ka sngi iew da ka jingphuhmat phuh samrkie ki la ia mih lang na la iing bad leitbeit sha ka kyntoit/basa die syiar. Ki da ia thied 5(san) tylli ki syiar bad ynda la poi sha shnong, ki la ia lum lang ha kawei ka jaka bad ia shet ia kita ki syiar bad ki sa ia bam ryngkat lang baroh bad ki khun ki kti jong ki.

Hadien ka jing ia dep bam baroh shi paralok ki la ia iit bniah ia ka jingurlong kata ka jingthmu ka jong ki bad khlem ka jingshaniah iwei ia iwei ka jingiakynshew lang, ka jingiatreilang khlem da wad daw wad dong, bad ka jingkhein jingdiah ba shai phar kum ka sngi ka wanrah iaka jingthmu ka ba jop kaba da pynhun lang ia baroh khamtam eh na ka bynta kine ki 15(khatsan) ngut shi paralok kiba im ha ka jingkyrduh ban wad iaka jakpoh tang da ka bylla sngi.

Na katei ka jingiathuh khana la lah ban pynshai ia ka Thymmei bad Nongrim (Principles of Cooperation) jong ka “Sengtreilang” lane “Cooperative” ia kiba iahap bad ki Rule (Principles) ba la pynjanai bad pynbha da ka Commission kaba thnung da ka International Cooperative Alliance ha u snem 1964 naka bynta ki “Sengtreilang” lane “Ki Cooperatives” ia kiba la niew ba ki long kiba donkam kiba shisha bad kiban treikam kumne harum:

## LYNNONG – II

# **KI THYNMMEI BAD NONGRIM KA SENG TREILANG**

## **(COOPERATIVE PRINCIPLES)**

Ka kyntien “Principles” ka mih naka ktien Latin “Principium” kaba mut ka “Thymmei” lane “Nongrim”. Ki Thymmei lane Nongrim jong ka “Sengtreilang” ki long ki jingmut bad jingthmu jong ka “laidshaphrang” ki “Sengtreilang” bad ngim dei ban sngewthuh bakla bad ki jingthmu treikam lane jingtrei, kiba dei hok ban pyndonkam ha ka jingtreakam jong ki “Sengtreilang” lane “Cooperatives”. Kine ki “Thymmei” lane “Nongrim” jong ki “Sengtreilang” lane “Cooperatives” ki long kumne harum:

### **1. Ka Monlade ba kloj ban trei bad ka jingpdiang dkhot ia baroh.**

Ki “Sengtreilang” lane “Cooperatives” ki long ki seng monlaitludi, kiba plie ia barok ban long ki “dkhot” lane “member” ia kito kiba lah ban pyndonkam ia ki jingtrei jingktah bad ba klou ban pdiang ka jingkitkhlieh kum u “dkhot” lane “member” khlem kano kano ka jingniew halor ka jingling brie, ka kyrdan imlang sahlang, ka niam, ka jait ka khong bad ka synshar khadar.

### **2. Ka jingpyniaid da u Paidbah bad rai da u Paidbah.**

Ki “Sengtreilang” lane “Cooperatives” ki long ki seng kiba pyniaid da u paitbah, na ka bynta u Paidbah bad jong u Paidbah kiba shimkhia bad iaitreilang haba pyniaid ia ki jingthmu treikam bad rai ia ka jingthmu treikam. Ki nongkitkam ba la jied (elected) jong kine ki “Sengtreilang” ki hap ban kitkhlieh bad shakri ia ki paradkhot.

### **3. Ka jingiasam mar ryngkat na ki jingmyntoi.**

Baroh ki dkhot lane member ki ia kynshew lane pynlang mar ryngkat bad pyniaid ia ka Seng ka dang jong ka seng da baroh u paidbah. Lada ka jingmih lane jingmyntoi ka don na ki jingtreakam ka dei ka jingioh jong ka Sengtreilang kaba sah lane tam na ka jingmyntoi lah ban pyndonkam ki paradkhot lane member da kaba ia bynta ne sam mar ryngkat kat kum ka jingkynshew lane ki shares kaba uwei pa uwei u dkhot/member u kynshew.

### **4. Ka jingpyrkhang ia ka sut/jingmyntoi halor ka Baiseng ka jinglong ba laitluid.**

Ki “Sengtreilang” lane “Cooperatives” ki dei ki seng laitluid kiba kyrshan ialade dalade bad pyniaid da ki paradkhot. Lada kine ki sneg ki ia don kti bad ka sorkar ne kiwei pat ki seng baheh lane ban wad jingiarap na kiwei pat ki sengtreikam, ki da leh ban pyndep kat kum ki kyndon da ka jingtrep ba thikna ha ka jingpyniaid paitbah ba synshar bad pyniaid da ki dkhot bad pynskhem ia ka jingling ba marwei bad laitluid jong ka Seng.

## **5. Ka jinghikai/jingtip shaphang ki “Sengtreilang”.**

Ki “Sengtreilang” lane “Cooperatives” ki pynbiang ia ka pule puthi bad jinghikai na ka bynta ki paradkhot ki nongkitkam ba la jied bad ia ki nongtrei khnang ba baroh kin lah ban pynmyntoi lane shakri kham kyrpang da kaba minot bad treishitom na ka bynta ka jingkiew bad jingroi jong ka Seng. Kane kan wanrah ia ki paidbah khamtam ia ki khun samla bad nongialam ka jingsngewthuh, jingshai kaba bniah bad janai ia ka jinglong, jingtreikam, bad ka jingmyntoi ba ioh naka “Sengtreilang” lane “Cooperatives”.

## **6. Ka jingiatreilang bad jingkitkhlieh hapdeng ki “Sengtreilang”.**

Ki “Sengtreilang” lane “Cooperatives” ki shakri na ka bynta ki dkhot jong ki kham janai bad bniah ban kyntiew shaphrang ia ka jingiaid jong ka Sengtreilang da kaba kawei ka “Sengtreilang” ka ia trei rynkat lang bad kawei pat ka “Sengtreilang” katkum ka jinglong ka jaka, ka puta, ka jingdon jingem bad ka jingtrei jingktah ba iasyriem naduh ha shnong, ha Nongbah, ha ka ri, bad shabar ri kumjuh.

## **7. Ka jingkitkhlieh na ka bynta ka imlang sahlang.**

Ki “Sengtreilang” lane “Cooperatives” wad lada ki khmih bniah na ka bynta ka jingmyntoi jong ki paradkhot, ki trei ban shakri ia ka imlang sahlang ha ka shnong ka thaw na ka bynta ka jingroi jongpar jong ka shnong. Ka dong bad ka jylla lyngba ki mat treikam ba la thmu bad pdiang da baroh ki dkhot.



# **LYNNONG – III**

## **MANO BA LAH BAN SENG IA KA “SENGTREILANG” NE “COOPERATIVE”.**

Baroh ki nongshong shnong ha ka jylla ki lah ban seng ia ka “Sengtreilang” ne “Cooperative” khlem da buh pud ia ka niam ka dustur, ka jait ka khong, lane ka kynja jaitbynriew ki ba don kajuh ka jingtrei ban iatreilang na ka bynta ka jingmyntoi jong ki, kaba da ka jingiarap lang, jingsngewthuh jingmut lang, khnang ban wanrah ia ka jingmyntoi bad ka jingiabynta ba mar ryngkat ha ka jingiohnong.

Katkum ka Ain jong ki Sengtreilang (Cooperative Societies Act) ha ka kyndon kaba (4) la batai shai ba ka Sengtreilang kaba don ki jingthmu ban kyntiew ia ka ioh ka kot, ka imlang sahlang jong baroh ki paradkhot katkum ki thymmei jong ki Sengtreilang lah ban pynrung ne register hapoh ka Ain jong ki Sengtreilang [Meghalaya Cooperative Societies Act, 2015 (Act No.11 of 2015)].

U/Ka briesh lane u dkhot jong ka Sengtreilang ym lah ban long u dkhot jong ka Sengtreilang, lymda u la dap pura 18(khatphra) snem snem ka rta; lait noh tangba lada ka kyndon treikam (bye-law) ka buh kaba bit bad khamheh ka rta.

Ka kyndon ba 6(1) jong ka Ain ki Sengtreilang (Meghalaya Cooperative Societies Act) ka batai bniah, ba ia kano kano ka Sengtreilang ym lah ban pynrung ne register hapoh ka Ain ki Sengtreilang (Cooperative Societies Act and Rules) lymda ka Sengtreilang ka kynthup ym duna ia ki 15(khatsan) ngut ki briesh kiba biang, ban kynshew ia ba bai seng lane ki shares, ban thaw ia ka pla tyngka kaban pyniaid ia ki jingtreikam bad ba ki dkhot ka seng ki shong ha kajuh ka jaka, ka shnong lane ha kajuh ka Block.

### **Kumno ban seng iaka “Sengtreilang” ne “Cooperative”. Ki jingdonkam ki long:**

- Ban seng iaki “Sengtreilang” ne “Cooperative Society” (i) ym dei ban duna ia ka 15(khatsan) ngut ki briesh kiba dei ban long uwei na kawei ka thliew iing ne ka dpei, (ii) u/ka ba la palat iaka 18(khatphra) snem ka rta kiba sah ha kajuh ka jaka bad kiba don ka jingthmu ban trei ia kajuh ka kam, (iii) kaba lah ban pynbiang ia kajuh ka jingdonkam, (iv) Ki dei ruh, kiba don ka jingthmu bad ka jinglong ba kloj ban pynbha iaka jingtrei da ka jingiatreilang katkum ki Thymmei lane Nongrim (Cooperative Principles) jong ki “Sengtreilang” lane “Cooperatives”.
- Ki 15(khatsan) ngut ia kiba la tip ne khot ki trai nongseng (Promoters) haba kia la ia kut bad rai lang ban seng iaka “Sengtreilang” lane “Cooperative” kin phah iaka jingkyrpad (application)

kaba la iasoi lang baroh 15(khatsan) ngut sha u Assistant Registrar of Cooperative Societies lane Sub-Registrar of Cooperative Societies uba don ha District lane Sub-Division da kaba kyrapad ia ka jingkwah ban seng ia ka “Sengtreilang” lane “Cooperative” da kaba kdew hangne harum:

- (i) Ka kyrteng ba la iajied lang ban buh na ka bynta ka “Sengtreilang” lane “Cooperative”
- (ii) Ka jingthmu treikam jong ka “Sengtreilang” lane “Cooperative” kaba hakhmat duh
- (iii) Ka jingsoi kyrteng jong baroh ki “Nongkyrshan” ne nongsdang baroh 15(khatsan) ngut.

Katkum ka kyndon 10 (1) jong ka Ain ki Sengtreilang (Cooperative Societies Act) ka aplikeshon ban pynrung lane register dei ban pynbiang sha u Registrar ha ka phom ba la shna bad suh lang ha ka sla ba la pyndait ha ka Rule jong ki Sengtreilang (Meghalaya Cooperative Societies Rule (Assam Rules – I of 1953 as Adapted by Meghalaya).

Ia ka aplikeshon dei ban da soi da kaba rit eh la kumo kumno 15(khatsan) ngut ki biew kiba long ki nongsdang ia ka seng.

Katkum ka rule 5(l) u Registrar u la ban kynjoh ktien ia u Deputy Commissioner lane Sub-Divisional Officer haba u sngewdonkam.

Ka trei lang lane co-operation ka dei kaba ka rim kum ka jingnang jingtip jong ka jaitbynriew. Ha u biew shisngi, ka trei lang ka mut ka jingiatreilang ha kano kano ka kam lane ka jingtrei. Ka nuksa ban kham shai ka long ka Dorbar Shnong haba baroh u nongshong shnong ki ia treilang ha ka iap ka im, ka shitom ka shipa jong ki para nongshong shnong.

Ki reiwshemphang jong ki Sengtreilang ha ka pyrthei baroh kawei ki batai ia kine ki Sengtreilang ha ki bynta bapher jong ka jingmut, kum karoi ka par, ka imlang sahlang, bad kiwei kiwei. Ka jingmut ba khamshai ba la pharia ki riewshemphang jong ka International Cooperative Alliance (ICA) ha ka jingialang ha Manchester, ha u snem 1995 la batai kumne harum:

“Ka Sengtreilang ka dei ka seng laitluid ba la pyniasoh da ka mon sngewbha ba laitluid jong ki biew ban kyntiew ia ka ioh ka kot ka imlang sahlang bad jingkyrshan lyngba ka jingiasnohkti lang, ka seng ba pyniaid da u paidbah, ia ki paidbah bad jong u paidbah (Democratic)”.

Katkum ka Ain ki “Sengtreilang” lane “Cooperative Societies” ba la tip kum ka Meghalaya Cooperative Societies Act, 2015 ka kyndon kaba 31(1) ka batai kumne harum:

ba la buh ha ka bye-law, tangba ka (Sorkar/Department) kan buh ia ki kyndon shaphang ka jingnang jingtip ba i donkam na ka bynta ki nongkitkam ka seng bad ki nongtrei.”

# KA JINGBUH JINGKHEIN JINGDIAH JONG KA SENG TREILANG (COOPERATIVE)

Ki Sengtreilang (Cooperative) ki long ki Seng kiba la pyniaid da ki paradkhot, ia u paradkhot bad ka jong u paradkhot. Ha ka jingtrei jingktah jong ka bynta ki Nongrep, ka jingsam ia ki sboh dawai, ka jingdie jingthied na ka bynta ki mar ba donkam ba pynmih ki paradkhot, ka jingpynmih ia ki mar ba shna da ki paradkhot bad kiwei pat ki kam ba ki Sengtreilang ki trei, donkam ia ka jingkhein jingdiah kaba shai kum ka sngi kaba pynhun ia baroh ki paradkhot jong ka Sengtreilang.

Na ka bynta kane, ki Sengtreilang hapoh ka jingpyniaid jong ka Managing Committee lane ki dkhot jongkitkam, ki donkam ban buh ryntih ia ki jingkhein jingdiah baroh ha ki kot ki sla ba donkam bad ioh ka jingkhein kaba biang bad khlem thohbria katkum ba la batai bad pynbeit ryntih da u Registrar ki Sengtreilang(Cooperative Societies).

Ka Managing Kommitti lane ki dkhot nongkitkam jong ka Sengtreilang baroh shisnem kata naduh 1(shi tarik) u bnai April jong uno uno u snem haduh 31 (laphew tarik) jong u snem ban wan ba ju khot u Snem kut Snem ki Sengtreilang(Cooperative year) lane kut snem jingkhein jingdiah(Financial year) ki hap ban buh ryntih ia ki kot jingkhein jingdiah ia kawei pa kawei ka jingtreakam jong ka Sengtreilang kiba dei ha ka thied ka pet bad ki jingioh bad jinglut baroh. Man la ka sngi haduh ba kut u snem.

- (A) Hadien ynda la kut u Snem, kata ha ka 31(Laphew-wei tarik) jong u bnai March, ki Sengtreilang ki donkam ban niew ia ki mar ki mata kiba sah baroh bad ban pynkhreh ka kitab (list) jong baroh da kaba buh ia ka dor thied jong kawei pa kawei ka tiar bad ban kheinlang ia baroh (Verification of Closing Stock) hakhmat ki dkhot nongkitkam lane u ophiisar jong ka Sorkar.

Hadien shisnem haba la dep pynbiang ia ka Kitab ba la soi lang da baroh ki Nongkitkam kiba don ha kata ka sngi ba shim jingkhein, u ophisar jong ka Sorkar yn sa soi bad ai ka jingpynshisha da ka jingthoh ia ka jingdon ki mar ki mata ha kata ka Sngi ba kut jong u Snem ba kumjuh ruh ia ka pisa ba don ha ka kti u Secretary jong ka Sengtreilang. Ia kane ka kitab, hapoh 15(khatsan) sngi dei ban pynpoi sha ki bor sorkar, ka Bank bad ban buh ruh shi kopi hapoh ka ophis treikam ka Sengtreilang khnang ban pynbiang rynrih ia ki jingkhein jingdiah ha kaba kut u snem (kata ha ka 31 tarik u March).

- (B) Kumba la kdew haneng, ba u nongkitkam (Secretary) yn hap han buh ia ki jingkhein jingdiah ba man la ka sngi naduh ba sdang u snem (kata naduh 1 tarik April) haduh ba kut u Snem (kata haduh 31 tarik u March), yn lum lang ia baroh ki kot (ki risit lane ki voucher) bad ia ki kitab jingthoh ba iadei ha ka die ka thied, ka jingioh bad jinglut ban pynkhreh ia ka Bui treikam ba

baroh shisnem jong ka Sengtreilang ha kine ki Saw bynta ba la kdew harum:-

1. Ka Kot jingthoh bad jingpynlut (CASH ACCOUNT) ba la lum thup lang ia baroh ha ka bui (General Ledger) naduh shi tarik u bnai April haduh ka laiphew-wei tarik u bnai March ia kaba lah ban pyni nuksa bad la pyndait lang hangne katkum ka jingsuh lang (Sla "A").
2. Ka kot jingkhein jingdiah kaba dei ba ki jingtrei, ka jingdie jingthied (TRADING ACCOUNT) ba la lum thup lang na ka bui (GENERAL LEDGER) kum ba kdew haneng (kata ha 1) la pyndiat lang hangne katkum ka jingsuhlang (Sla "B").
3. Ka kot jingkhein kaba dei bad ka loh ka Duh (PROFIT AND LOSS ACCOUNT) ba la lum thup lang na ka bui (General Ledger). Kumba la kdew haneng (kata ha 1) la pyndait lang hangne katkum ka jingsuhlang (Sla "K").
4. Ka kot jingkhein jingdiah kaba dei ka jingdon jingem(BALANCE SHEET) ba la lum thup lang na ka bui(GENERAL LEDGER) bad na ki kot ban pynbiang ia ka jingkhein jingdiah (Adjustments). Kumba kdew haneng (kata ha 1) la pyndait lang hangne katkum ka jingsuhlang (Sla "D").

Hadien ba u Nongkitkam (Secretary) bad baroh ki Nongkitkam ki la hun bad pynbiang ia katei ka Bui treikam ba baroh shisnem, ia kaba dei ban pyndep hapoh shibnai naduh ba kut jong u snem, ka ophia jong u Asstt.Registrar/Sub-Registrar kan phah ia u Ophisar(Departmental Auditor) sha ka ophis treikam jong kaSengtreuilamg ban buh ia ka sngi bad ka por na ka bynta ban peit bad iit bniah ia katei ka bui treikam bad baroh ki kot ki sla,ki register,ki rusit bad baroh ki jingdonkam ba dei ban pynbiang.

Ynda u ophisar u la hun ba katei ka bui treikam ka iahap bad ia mynjur bad ka jingbuuh jingkhein jingdiah khlem don kano kano ka jingbakla,wat lada don ladep pynbeit baroh, yn ai da ka jingthoh ba pynshisha (Audit Certificate) kaba dei ban rung ha ka kot jingdon jingem (kata ka sla'D') ba la soi da u Secretary bad u Chairman ka Sengtreilang ryngkat ka muhor bad jingshem jinglap jong u(Audit Report) ban suh lang.

U Nongkitkam (Secretary) ynda u la ioh pdiang ia ka report jingshem jinglap(Auditor's Report) na u ophisar yn wanrah ia kane ka report bad ia ka bui-treikam ba la dep iit bniah da u ophisar ha ka jingialang jong ka Managing Komitti kaba dei ban long hapoh artaiew hadien ba la iohpdiang ia ka report.

Ka managing komitti kan iatai halor ka bui treikam bad ia ka report ba la dep iit bniah da u ophisar khnang ban wanrah sha ka jingialang paitbah ba shisien shisnem jong ka sengtreilang kaba dei ban long hapoh shibnai hadien ba la dep long ka managing komitti. Kata ka report jingtrepikam ba la dep iit bniah bad ka report jong u ophisar(Auditor) yn pule bad pdiang da ka jingialang paitbah jong baroh ki dkhot ka Sengtreilang khnang ba baroh ki dkhot baroh kin iohlad ban ai jingmut ban pyniar, pynbha bad pynmyntoi ia baroh katkum ki kyndon Treikam (Bye-Law) bad ka Ain, ka Rule jong ki Sengtreilang(Cooperative Societies Act and Rules).

Ka rai jong ka jingialang paitbah ba shisien shisnem ia kaba la dep pynlong kumba la kdew haneng dei ban phah sha u Asstt.Registrar/Sub-Registrar ryngkat ka Report jingtreikam ba la dep pdiang da kata ka jingialang paitbah, ki jingthmu treikam na ka bynta u snem ban wan ba kynthup ia ka mang tyngka, ka jingjiied ia ki Nongkitkam bad kiwei kiwei. Shi kopi na kitei ki kot dei ban da buh bha ha ophis treikam ban wanrah ia ki jingthoh jingtar ba beit ba ryntih,ba pynhun ia ki paradkhot ha ka jingpyniaid paitbah jong kano kano ka Sengtreilang(Cooperatives).



## **LYNGNONG - XII**

### **KA JINGIABYNTA NA KA JINGIOHNONG KA SENGTREILANG(COOPERATIVES)**

Kawei na ki mat jong ki Nongrim Ka Sengtreilang (Cooperative Principles) ka long ba ia ka jingiohnong lane jingmyntoi ba ka Sengtreilang ka ioh na ki jingtreikam, dei ban iasam ryntih bad maryngkat sha baroh ki paradkhot(Equitable distribution of surplus/profits).

Ka kyndon ba 31(1)(d) jong ka Ain ki Sengtreilang (Cooperative Societies Act) ka pynkup bad aibor ia ka jingialng paitbah ba shisien shisnem jong ka Sengtreilang ban pyrkhat ha kano ka rukom ban iasam ia ki jingiohnong/ jingmyntoi katkum ka kyndon treikam(Bye-Law)jong ka sengtreilang.

Halor kitei ka mat ba kdew haneng,ka pyni shai ba ka Sengtreilang kaba don ka jingiohnong na kano kano ka jingtreikam jong ka, ka donkam ban iasam/bynta ia kata ka jingiohnong/jingmyntoi man la u snem.

Katkum ka kyndon ba 53(1) jong ka Ain ki Sengtreilang ka pynkup bad aibor ba kawei pa kawei ka sengtreilang ka dei ban buh ka Pla Tyngka Ba Kyrpang (Reserve Fund) ba la shna na ka jingiohnong/jingmyntoi bad ban rah sha katei ka Pla Tyngka(Fund) man la u snem ym duna ia ka 25(arphewsan) na ka shispah na ka jingiohnong jong ka sengtreilang.

Ia kane ka Pla Tyngka (Fund) ym lah ban iabynta lane iasam ,yn ym don uno uno u paradkhot u ba lah ban kam lane iohbynta na kane ia kaba la kdew bad batai katkum ka Rule56(1) jong ka Rule ki Sengtreilang (Cooperative Societies Rules).

#### **BAN PYNDONKAM IA KA PLA TYNGKA BA KYRPANG (RESERVE FUND)**

Katkum ka Rule 58 jong ka Rule ki Sengtreilang (Cooperative Societies Rules),ka Sengtreilang, da ka jingaibor u Registrar bad kiwei pat ki kyndon kaba u lah ban leh, kan pyndonkam ha ki jingtreikam kumne:

- (i) Haduh kawei na ka lai bynta na ka pla tyngka ba kyrpang(Reserve fund) haba ka baiseng la jong kan ym duna ia ka baiseng da ka kylliang.
- (ii) Haduh ar na ka lai bynta na ka pla tyngka ba kyrpang(Reserve Fund)kaba ka baiseng la jong ka iaryngkat lane ka twm ia ka baiseng ba kylliang(borrowed Capital).
- (iii) Baroh ka Pla Tyngka ba Kyrpang(Reserve Fund) haba ym don ka baiseng da ka kylliang.

Tangba, ka Sengtreilang ka bym dei ka Sengtreilang ba airam aishah ka lah, da ka jingaibor kyrpang jong u Registrar ban pyndonkam ia baroh ka Pla Tyngka ba Kyrpang(Reserve Fund) na ka bynta ki jingtreikam ba kyrpang.

Ka Sengtreilang kaba treikam bad iohnong man la u snem lane ha uno uno u snem hadien ba ka la pyndep ia katei ka kyndon ba la buh katkum ka kyndon ba 54 jong ka Ain ki Sengtreilang, ka lah ban iasam iaphiah ia kata ka jingiohnong katkum ki jait bad dor ban ia bynta ba la buhbeit ryntih ha ka kyndon treikam (Bye-law) ka Sengtreilang kiba lah ban long kumne harum:

- (i) Ka jingkynshew sha ka pla tyngka ka roi ka par ki sengtreilang. –Cooperative Development Fund.
- (ii) Ka jingsiew (Dividend) halor ki bynta(shares) jong ki paradkhot/ Sorkar lane kiwei kiwei. – Payment of Dividend on Shares.
- (iii) Ka jingsiew/ai sngewbha na ka bynta ki paradkhot lane nongtrei.-Payment of bonus or remuneration.
- (iv) Ka jingpynap ia ki ram ba sniew bad artatien.- Provision for Bad & Doubtful debts.
- (v) Ka jingpynap na ka bynta ka Pla Tyngka ban shna ling/shna sem.-Provision for Building Fund.
- (vi) Ka jingsiew sut Halor ka bynta Bai Seng.- Payment of Interest on Share Capital.

Ha ka jingiaid shaphrang ki Sengtreilang ha ka jylla jong ngi, la shem ba bun na ki Sengtreilang wat napdeng kiba long kiba ha khlieh bad khamtam kiba rit, bunsien ki iaidlait ia la ka jong ka Kyndon Treikam(Bye-Law) ia kaba ki la pynwandum bad shna kyrpang na ka bynta ka jingtreikam jong ka Sengtreilang.Ka paw shai ba bun na ki, ki pynkhein ia ka kyndon ba 54 jong ka Ain. Kane ka wanrah ka jingkyrduh ka Pla Tyngka jong bun ki Sengtreilang wat la ki don ki jingthmu ban kyntiew ia ka roi ka par, ka khaii ka pateng jong ki paradkhot bad ka shnong. Lada wad bniah bad tih jylliew, lah ban ong, ba wat ia ka baiseng ba la kynshew da ki paradkhot lane ka Sorkar da ka jingthied ia ki bynta(Purchase of Shares), la pyndonkam bakla lane bamduh (eroded) kaba ialam sha ka jinglot bad jingbymlah ban ieng ha la ki kjat haduh kine ki sngi.

Kumta ki paitbah lane ki paradkhot jong ki Sengtreilang ki donkam ban sngewthuh shai ba lada ka Pla Tyngka Ba Kyrpang (Reserve Fund) kam don hapoh ki Sengtreilang, kita ki Sengtreilang kim lah ban long kiba khlain ne ki ban neh ha ki jingtreikam katkum ki jingthmu, kaba lah ban wanrah ia ka jingartatien, ka jingduh jingkyrmen ia ki paradkhot ha bun ki liang, kiba long ma ki, ki nongkyrshan bad nongseng jong ki Sengtreilang.

Kum u shakri barit, ka long kaba sngewsih ban kren pyrshah haba iohi bad iohsngew ba bun na ki Sengtreilang(Cooperatives) ha ki thain Khasi ,Jaintia bad Ri-Bhoi District wat la ki la bun ha ka jingroi bad trei ki kam bapher ba pyni ia ka roi ka par,bun napdeng jong ki kim don tang ka Sign-Board lane ka jaka treikam(Ophis) kaba paka.Kane ka wanrah ia bun ki jingeh khamtam ia ki briel bad ki Ophisar baheh jong ka sorkar haba ki iuhkjat ha ki shnong ba don kine ki Sengtreilang.Kaba kham shon, ka long ba wat u marjan marpa napoh ka shnong ym tip wat ia ka kyrteng lane wat ia ka ophis treikam jong ka.Bun lada jia ba leit wad ia kum kine ki sengtreilang la hap ban shu kylli . hangno ka sengtreilang jong u lane ka Bah/Kong ‘A’ lane ‘B’. Kane ka pypnaw ia ka dur treikam jong ki Sengtreilang ha kine ki sngi ha kaba ka jingiashim bynta jong ki paradkhot kam don namar ki nongtrei bad ki nongkitkam kim pyniaid ia ka Sengtreilang katkum ka Kyndon Treikam(Bye-Law) bad pynkhein ruh ia bun ki hukum lane ki kyndon jong ka Ain ki Sengtreilang(Cooperative Societies Act & Rules). Kine ki sengtreilang ki long kiba laitluid (Democratic Control), ba pyniaid da u paidbah, na ka bynta u paidbah bad ka jong u paidbah.

1. Kano kano ka kynhun kaba kynthup ia ki kynthei bad shynrang lane tang ki kynthei , lane ki Group kaba ym duna ia ka 15(khatsan) ngut kiba la dap paka 18(khatphra) snem ka rta , kiba sah ba shong ha ka wei ka jaka, kiba don kajuh ka jingtrei jingktah, kiba don ka wei ka jingthmu ban trei kajuh ka kam ki lah ban seng ia ka Sengtreilang(Cooperative Society) katkum ka jingdon jingem kaba don hapoh ka shnong /ki shnong, bad ban rung dkhot u wei/kawei na ka wei ka thliew iing.
2. 9. Katkum ki report kiba ngi tip kum ka Annual Report bad ka Audited Balance Sheet la ju lap ba bun na ki Sengtreilang (Cooperative Society) ki duna palat ha ka jingkynshew lane thied ia ki share da ki dkhot jong ka Sengtreilang (Cooperative Society) bad bun na ki kim lah ban pynbiang lane pyndap ia ka baiseng treikam (Paid-Up Capital) bad ki kylla long ki seng kiba tlot ha ka jingkynshew ia ka baiseng baidang (capital formation). Don bun na pdeng ki Sengtreilang (Cooperative Society) ha ka Jylla kiba u/ka dkhot jong ki , ki thied ia ka share na ka seng tang shisien thied tang ban iohlong dkhot da kaba pynkhein ia ka jingthmu treikam ka Sengtreilang (Cooperative Society).

Katkum ka jingpeit ha kine ki por la lap ba ki Sengtreilang (Cooperative Society) ki long da khongpong bad ki la kylla long ki seng ba la pyniaid da ka sorkar (Government driven organisation).
