3. BADIA BI·APO KAM KA·GEN:

4. COOPERATIVE SOCIETYNI MIKSONGANI:

Cooperative Societyni mongsongbatgipa miksonganide membör rangni aro songni nokdangrangna janggi tangani gadangko nambatatanı ong·a, uamangni ge'a gamani bdingoba ongbo ba bostu tariani bidingoba ongbo uko nambatate tangka paisa man'aniko tangdoatna miksonga. Bading chiwalanina che·em che·em tarisamsoe member rangchi dingtang dingtang tangka man·ani cholrangko nambatatanı aro monsongbate ka·mao janaparangko dakatani ong·a :-

- (l) Kosako janapgipa rangko dakna ba je dakgipa bading chiwalani kamrangko somoioni kri societyni membor jinma tom'e chanchianio pangchake ka'na jekae e'ching, alikka, rubber, mi, kil ba gipin rang jeko dakanichi kosako janapgipa mansongani ba mangsongani rangko chu'sokatna man'gen.

5. MEMBOR

5:1 (a) Membor ong'na man'nani:

Societyo membora ong'na ba bimung gatna sakantian bilsa 18 gapna nanggen aro jemangan songo ba bi'apni mande ong'e a'a ba ugita dakgipa mojimatna man'gija gipa gam donga uamang membora ong'a man'gen.

5:1 (b) Membor ong'na dorkasto galgipako societyni bye-law ba ni amo pangchake rimnapna nanggen aro uamangni membora ong'aniko mesokna uamangni bimungko societyni membora registero gatna nanggen jeon sakanti memborni soi ka'ani aro jaksi tapani donggen aro uamang sakantinan nangchomotgipa ui'atna nanganiko ui'atna nanggen.

Societyko chalaina seokgipa dol ba managing committee name chanchirimani jamanosa memborko ra'chakani aro jegalaniko dakgen aro uni bak rangsi breniko ra'chakani ba ua badita bak rengsi brena am'engachim ukoba komiataniko dakgen; indiba membora jean societyna bosturangko tarianio chamgimin dolmahana kam ka'a uni membora ong'aniko jegalna man'jawa aro uandakgipa manderangko society membora ong'na dorkasto gala ine ra'na nanggen bye-law 5 (12) o janapa gita uamang share ba bak rengsi ge'sa brena man'naona kingking uamangko membora ine channa nanggen.

5:5: Membor ong'aniko on'jitani:

Tom'anina katta bichongo janapgipa na agreba gipin chanchianirangko tom'anio donggipa bak gittamni bak gni member rang namnikode aro uani miksongani bye-lawko dingtangatna (amendment), sakoba memboroniko a'rikna ba sorkarini officeo kam kagipako a'rikna miksongjaode ukoba chanchianiko dakna man'na.

6:3(d) Chairman:
